School Enrollment & Attendance (School Year 2014-15)

School districts receive financial support from the state for the education of the students they serve based on how many students attend school each day. More importantly, attendance is critical to academic achievement, and regular daily attendance is a priority at Adelanto Elementary School District. Attendance, tardiness, and truancy policies are clearly stated, consistently enforced, and consequences fairly administered. Parents are advised of their responsibilities, including proper notification of when and why students are absent. Absence reports are regularly reviewed by the school secretary. Parents are informed of absences through phone calls and letters sent home. Students can attend Saturday School to make-up absences.

Students are referred to the district's School Attendance Review Board (SARB) when they have persistent attendance or behavior problems in school, and when the normal avenues of classroom, school, and district counseling have proven to be ineffective. The SARB is composed of parents, representatives from the district, and members of the community, including representatives from law enforcement, welfare, probation, and mental health agencies. The members of SARB, the referred students, and their parents or guardians meet regularly to evaluate the student's situation and recommend alternative solutions to alleviate circumstances that contribute to specific truancy, attendance, or behavioral problems.

California Assessment of Student Performance and Progress

California EC Section 60640 authorized the replacement of the Standardized Testing and Reporting (STAR) Program with a new assessment program, referred to as the CAASPP. All students in grades three through eight and eleven were assessed using computer-based tests in English/Language Arts and Mathematics; students in grades five, eight, and ten were also tested in Science. Science assessments were paper-based and included California Standards Tests (CSTs), California Modified Assessment (CMA), and California Alternate Performance Assessment (CAPA). Students receive an overall score for each subject, ranging from 2,000 to 3,000. Overall scores are reported within one of four levels:

- Performance Level 1: Standard not met - Needs substantial improvement for success in future coursework.
- Performance Level 2: Standard nearly met - May require further development for success in future coursework.
- Performance Level 3: Standard met - Demonstrates progress toward mastery.
- Performance Level 4: Standard exceeded - Demonstrates advanced progress toward mastery.

ELA results include information about the students' performance in the areas of reading, writing, listening, and research. Reports of mathematics results include information about students' performance in problem solving, using concepts and procedures, and communicating mathematical reasoning.

Discipline & Climate for Learning

A warm, nurturing atmosphere and an effective learning program provide the basis for West Creek Elementary School's discipline program. The entire school staff supports an environment that encourages well-behaved students who are focused on learning.

School rules and policies are distributed at the beginning of the school year in the Teacher's Welcome Back Letter and through the district and school student handbooks. Throughout the year, school rules and policies are reinforced through the Wednesday Envelopes, monthly newsletters, behavior assemblies held three times a year, Back-To-School Night, and Open House. The school also utilizes e-mail, parent meetings, parent-teacher meetings, and phone calls to communicate with parents.

Safe School Plan (School Year 2015-16)

The safety of students and staff is a primary concern at West Creek Elementary School. The Comprehensive Safety Plan was developed by the school in consultation with local law enforcement in order to comply with Senate Bill 187 of 1997. The plan provides students and staff a means to ensure a safe and orderly learning environment. Components of the Comprehensive Safety Plan include the following: child abuse reporting procedures, teacher notification of dangerous pupil procedures, disaster response procedures, procedures for safe drop-off and pickup from school, sexual harassment policy, and dress code policy. West Creek Elementary School reviews the plan annually and updates it as needed.

The plan was last updated in the fall of 2015 and reviewed with school staff. A copy of the safety plan is available to the public at the school office.

Fire drills are conducted on a monthly basis while earthquake and intruder drills are conducted three times a year. The school is in compliance with all laws, rules, and regulations pertaining to hazardous materials and state earthquake standards.

To ensure student safety, educational aides, the principal, and teachers supervise students at all times before, during, and after school. The designated area for student drop off is at the front of the school and pick up is at the front of the school and the kindergarten area.

While West Creek Elementary School welcomes visitors to the campus, appointments should be made with the principal for in-class observations. All visitors must sign in at the office, obtain a visitor's badge, and sign out upon leaving.

Adequate Yearly Progress (AYP) (School Year 2014-15)

No Child Left Behind (NCLB) is a federal law enacted in January 2002 that reauthorized the Elementary and Secondary Education Act (ESEA). It mandates that all students (including students who are economically disadvantaged, are from racial or ethnic minority groups, have disabilities, or have limited English proficiency) in all grades meet the state academic achievement standards for mathematics and English/language arts by 2014. Schools must demonstrate "Adequate Yearly Progress" (AYP) toward achieving that goal. The Federal NCLB Act requires that all schools and districts meet the following Adequate Yearly Progress (AYP) requirements:

- Participation rate on the state's standards-based assessments in English/language arts (ELA) and mathematics.
- Percent proficient on the state's standards-based assessments in ELA and mathematics.
- Graduation rate (for secondary schools).

There are several consequences for schools that do not meet the AYP standards, including additional tutoring and replacing of staff. Students would also be allowed to transfer to schools (within their district) that have met their AYP, and the former school would be required to provide the transportation to the new site. Federal Intervention Program (School Year 2015-16)

After two consecutive years of failure of a particular subgroup to meet AYP goals, Title I schools become eligible for Title I Program Improvement (PI). Schools can be categorized as PI for a maximum of five years, however, a school may exit from this status after two consecutive years of success in the affected subgroup(s). There are several possible consequences for schools that do not meet the AYP standards including: curriculum changes, providing technical assistance and coaching for staff, additional tutoring and interventions for students, and transporting students requesting transfers to other schools within the district.

Library & Computer Resources

The school's library, staffed by a part-time library media specialist, provides an extensive variety of reference and special interest materials, in addition to hundreds of educational and recreational books. Students visit the library on a weekly basis with their classes and can access the library during recess. The library also contains a computer lab with 32 workstations that are connected to the Internet to provide students with additional research resources and information online. Additional instructional materials within the library include the Listening Center and a television that is connected to DVD players.

Computer skills and concepts at West Creek Elementary School are integrated throughout the standard curriculum to prepare students for technological growth and opportunities. Each classroom contains at least one Internet-connected computer, an ELMO, and some classrooms have InterWrite SchoolPads. There are six Chromebook carts for classrooms to share. The school's 32 station computer lab is located in the library and trains students on the following software programs: Accelerated Reader, MS Works, and PowerPoint.

It is the goal of Adelanto Elementary School District to assist students in their social and personal development as well as in academics. The district provides special attention to students who experience achievement problems, difficulty coping with personal and family problems, trouble with decision making, or handling peer pressure.

An active Student Advocacy Team (SAT) meets regularly to address issues that affect the ability of a student to achieve in school. Using a collaborative approach, members of the SAT evaluate and recommend various intervention strategies and services to meet the unique needs of the referred student. *The counselor to pupil ratio is 1:595.* The chart indicates the support staff available to assist all students at West Creek Elementary School. Note: One Full Time Equivalent (FTE) equals one staff member working full time; one FTE could also represent two staff members who each work 50 percent of full time.

West Creek Elementary School provides additional services for students with special needs, as identified by an Individualized Education Plan (IEP). Students identified as "at-risk" may receive additional assistance from a district intervention team, as well as RSP instructional aides.

A Resource Specialist Program (RSP) teacher assists students in class and on a pull-out basis. Students in the Special Day Class are mainstreamed whenever possible.

West Creek Elementary School provides English Learner (EL) students with 30 minutes of ELD instruction each day. Students are grouped according to their English language acquisition as determined by the CELDT test.

The school also participates in Think Together, an three hour educational enrichment program that compliments the school's academic programs by offering tutoring, homework assistance and an array of services and activities.

West Creek Elementary School also offers several avenues of tutoring assistance for students:

- Intersession Intervention
